You should be notified directly by Toyota if your vehicle is affected by the extended evaporative emission control system warranty. The chart above may be helpful for you to determine whether your vehicle is affected.

1. Check the chart: If your vehicle model and model year is listed in the chart your vehicle may be covered by the extended evaporative emission control warranty. Your vehicle should be covered by the Toyota extended evaporative emission control warranty if your vehicle's engine family and evaporative family are included in the above table. In addition, 1998 model year vehicles are covered only if built on or before a specified date in 1998.

2. Check your car:

- a. The engine family name and evaporative family names are on the vehicle emission control information label applied by the manufacturer. The label can usually be found under the hood, permanently affixed to a component or the hood, in a location that is readily visible. (This label will contain other information about your vehicle, such as tune up specifications and a description of the emission control components installed on your vehicle.)
- b. The build date is usually stamped on a label affixed to the inside edge or bottom of one of the two front doors. Your 1998 model year vehicle is covered by the Toyota extended evaporative emission control warranty only if it was built on or prior to the date listed in the right hand column of the above table. This limitation does not apply to model year 1996 and 1997 vehicles.
